Minutes of the Havre des Pas Improvement Group meeting held on Thursday 12th January 2023

2	<p>Approval of minutes of the meeting held on 12 January 2023</p>	
	<p>The minutes were hereby approved.</p>	
3	<p>Update from IHE (Deputy Binet) - to include, with Marcus Calvani, The Lido (Havre des Pas) Limited</p>	
	<p>Deputy Binet apologised for not having attended the meeting in a while and opened the floor up to updates that were needed.</p> <ul style="list-style-type: none"> An update on Havre des Pas Gardens was requested. TB asked that the photos of the gardens we resent to him so that he could investigate this. TB provided an update on plans for Fort Regent – a property review is to be undertaken to find out how much it will cost to make the building structurally sound and safe for public use and how it can be used in the near future without spending lots of money. He confirmed investigative work was beginning on how best the green spaces at Fort Regent could be used. A lot of queries were raised regarding proposed plans for the lift to Fort Regent and issues around accessibility. TB confirmed he will obtain the plans for the lift. The focus groups organised by 4 Insight were raised as residents queried who was organising them and who was the feedback being reported back to? TB confirmed he was going to obtain a copy of the information and look into this. TB confirmed that the Ommaroo zebra crossing has been held up due to equipment delays and is due to be implemented as soon as the equipment arrives. Issues on Green Street regarding buses meeting in the middle and cars and buses mounting the pavements were raised. TB is to speak to Liberty Bus about what can be done. <p>The Lido update:</p> <p>MC explained the breakdown in relationship between himself as tenant and Jersey Property Holdings 'JPH' over the past few years. Explaining that most recently, he had received a letter from IHE, which was initiated by the landlord, to state he had made unauthorised changes inside a listed building and now had to go through a retrospective planning permission process. He also confirmed that he was still having events cancelled as a result of the landlord.</p> <p>MC confirmed that independent mediation was to begin. He also stated that the Lido is opposed to mediation on the grounds that the Lido does not know what the issue is to be able to mediate.</p> <p>MC invited all residents to write letters of support to be used in the mediation process. 	<p>TB replied to MC to say that from evidence he has seen the situation has been chaotic on both sides and he hopes to be an impartial middle man to review what's gone on, where we are now and how we can move forward in the best way for both sides.</p>
