

## Minutes of Waterfront Residents Association meeting 24<sup>th</sup> September 2024

1. Apologies received from Deputy Coles, Lee Henry, Constable Crowcroft, Linda Fairfield, Andre Sty, Paul Baxter and Peter Daniell
2. Minutes of 30th July 2024 approved
3. Matters arising –

A degree of frustration was voiced at the length of time it is taking to get crossings installed on Rue de L'Etou.

Deputy Warr putting in an oral question to the Infrastructure Minister in the Assembly to find out more.

4. Lee Henry could not attend this meeting but the following was received:

Bollards – complete the installation of the automatic dropping bollards – End October 2024

Bollards – reinstatement of fixed bollards that have been removed to get around non-usable automatic bollards – end October 2024

3 x pedestrian crossings – carry out the installation of ped crossings on Rue de L'Etou – 3-4 months from Ministerial approval

Cycle parking on Marina Gardens and outside Fitness first 0 install additional cycle racks – 1 week from delivery – target End October 2024

Underpass link – fencing widened, white-lining the required vehicle approach to the hairpin bend. – complete

Bollards – installation of additional fixed bollards around Horizon footpath – End November 2024

Finally, just to confirm given some confusion at the last meeting, the Horizon footpath and service layby on Rue de l'Etou was legally conveyed to the Parish on 21 June 2024.

5. Policing initiatives – PC McCallam and PC O'Neil

From minutes there has been no progress on cycling initiative this is due to a change in the head of road traffic.

Update on logs –

No issues or concerns raised to end July

Anti-social driving log has also been closed

Other general issues –

Couple sleeping rough now accommodated

Setting off of fire alarms / extinguishers – individuals identified but no prosecution

We were read out a definition of anti-social behaviour

Metropolitan police:

Antisocial behaviour is defined as 'behaviour by a person which causes, or is likely to cause, harassment, alarm or distress to persons not of the same household as the person'

DDW to raise issue with ports. Note after meeting DDW approached by Ports officers and advised that they would deal with this matter.

DDW to raise this with Constable Crowcroft as to what is offered by the Parish for their town hall meetings? A short term solution has been found whilst this issue is investigated.
