	Paul Coundley spoke on behalf of a provisional application for a 6 <sup>th</sup> category licence, for the Coop, Phillips Street. Mr Coundley explained the application was for a new store, which would be located opposite the Art Centre. There has been considerable investment in the area and new housing developments built in Bath Street and at the end of Phillips Street. The Coop plans to run the store, like their Val Plaisant and, Charing Cross branches. The store will be open between the hours of 7am to 8pm, seven day a week The store will stock beers, wines, and spirits. Store managers are trained in the licensing law and the required practices. The Coop gives back through its community fund by supporting good causes and local organisations.  Chef de Police, Danny Scaife asked Mr Coundley for further details in relation to staff training. Mr Coundley advised that the selling of alcohol is covered as part of new employee's induction training and the company takes its responsibilities seriously, providing regular refresher training.				
	Procureur John Baker stated he had recently shopped in a store where he noticed someone shoplifting, can the Assembly be assured that the Coop has practices in place to prevent the shoplifting of alcohol.  Mr Coundley stated that unfortunately there had been an increase in shoplifting because of the financial crisis. The company has CCTV installed in their shops and undertakes regular stocktaking. Where there is a discrepancy, they can follow back the footage. Staff are very aware of the risks of shoplifting and escalate their concerns immediately. The Coop work closely with the Police in this matter.				
	Procureur Baker stated that he had seen security staff on the door of the Charing Cross branch and wondered if a new store would benefit from such measures.				
	The Assembly had no further questions, on being put to a vote the application was approved unanimously.				
	The Chair advised the Assembly that anyone who had spoken in respect of the Licensing application, was				
	entitled to address the Extraordinary Sitting of the Licensing Assembly, which would take place at 9:30am on
