OPEN MEETING	Having been previously circulated, the 'A' Agenda Minutes of the meeting held on 21st May 2025 were approved.	
MATTERS ARISING	None	
56/2025 VALLEE DES VAUX CONCERNS RAISED	Residents of Vallee des Vaux addressed the Committee, raising several concerns. It was felt there had been no consultation with those living in the area before the road calming initiatives were introduced. (SA) confirmed there had been extensive consultation with residents, including letter drops, media and social media releases, plus site notices, which invited the public to come forward for discussion or to express concern.	
	Residents raised concerns about the current layout, stating the pedestrian road and bollards are dangerous, as the pedestrian road is not for shared use; and two-way traffic, cyclists and horse riders are having to negotiate a narrower width of road. The blind corners, lead to near misses daily, with traffic having to pull over between the barriers which are not wide enough, forcing cars over onto the pedestrian lane and damaging the bollards.	
	Even though the road has a 15mph speed limit, due to its length, people get impatient and regularly go above the speed limit; residents believe 25mph is the average speed. Users are often subjected to verbal abuse when they try to advise the public of this.	
	The residents suggested speed bumps and/or rubble strips would improve the area. (SA) advised that whilst these reduce speed, they are expensive and can be noisy for those living in the vicinity.	
	It was suggested that a working group from the Parish, join with the residents, to explore options and to consider the cost implications and viability.	
	The Committee agreed unanimously for the Working Group to be set up – (HH) to lead.	

## 57/2025 AIR QUALITY IN ST HELIER

A member of the public Mr Brice Harris (BH) presented his concerns on the air quality in St Helier.

As a non-driver in St Helier, he feels that the level of air pollution from cars puts his and others health at risk. In his one-hour commute to and from work, he feels and smells the pollution. Even in St Helier "Green Spaces", such as the parks and cemeteries, the smell of pollution can be noticed and the noise from cars disruptive.

The Committee thanked him for his presentation and agreed that air pollution and vehicle use in St Helier is an ongoing problem. The Parish is seeking to address this with the implementation of more pedestrianised areas, tree lined routes, green spaces and softer furnishings.

The Government measure air quality daily, with air quality data being available on their website.

The Committee agreed they would consider air quality, when undertaking future projects within St Helier.

## 58/2025 E-SCOOTER REPORT UPDATE

(BM) presented a paper on E-Scooters.

The Committee unanimously agreed the information, and the proposal to look at legislation to enable E-Scooters to be made legal, for use on St Helier's roads. It was thought that the paper was informative and should be put to a Parish Assembly for its backing.

The Committee was advised by (JL) that the Government has set up a working group which have met twice, with the next meeting addressing questions and possibilities.

It was agreed that the Roads Committee should wait to see the outcome of this meeting, before the matter is presented to a Parish Assembly.
