## PARISH ASSEMBLY

- 3. recommend to the Licensing Assembly an application by Cineworld Cinemas Limited, holder of a Seventh Category licence in respect of Cineworld, The Waterfront to vary the conditions of the licence to increase the number of patrons permitted in specific areas on the premises as follows; First Floor bar area increase from 100 to 200 VIP 1A increase from 12 to 18, VIP 1B increase from 12 to 18 VIP 10A increase from 8 to 12;
